Facilities for which permits are issued shall be operated and managed in accordance with Standard 590 of the Technical Guide.

The undersigned also agrees to certify in writing, upon installation of the facility that the facility was installed as planned. Deviations from the original plan must be reviewed and approved by the Grant County Land and Water Conservation Department prior to installation. The Grant County Land and Water Conservation Committee or its staff shall be allowed upon lands affected / this ordinance to inspect the land prior to or after permit issuance to determine compliance with this ordinance.
